

ARTICLE 1

NAME

The name of the limited liability company is:

DIJO IN USA, LLC

ARTICLE 2

PURPOSE AND POWERS

- Purposes. The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated by the written approval by a majority of the Members of the Company and the approval of the Manager of the Company.
