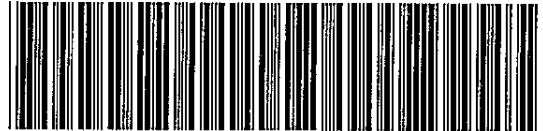

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I - NAME

The name of this Limited Liability Company is PREMIER PROPERTY SOLUTIONS, LLC.

ARTICLE II - MAILING ADDRESS

The mailing address of the principal office of PREMIER PROPERTY SOLUTIONS, LLC, is P. O. Box 721663, Orlando, Florida 32872-1663 and the street address of the principal office of PREMIER PROPERTY SOLUTIONS, LLC is 8987 Fort Jefferson Blvd., Orlando, Florida 32822.

ARTICLE III - DURATION

The period of duration for PREMIER PROPERTY SOLUTIONS, LLC shall be perpetual from the date of filing these Articles with the Department of the State, except for the limitations set out in Florida Statutes Section 608.441.

ARTICLE IV - REGISTERED AGENT & OFFICE

The name of the initial registered agent is BENJAMIN YONGE. The street address of the initial registered agent is 8987 Fort Jefferson Blvd., Orlando, Florida 32822.

ARTICLE V - ADDITIONAL MEMBERS

Additional members to the Company may be admitted, but only if all the current members agree to the admission of the additional members and to the terms of admission.

ARTICLE VI - TERMINATION OF MEMBERSHIP

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in PREMIER PROPERTY SOLUTIONS, LLC, the remaining members may, by unanimous agreement, continue the business of PREMIER PROPERTY SOLUTIONS, LLC.

ARTICLE VII - MANAGEMENT

PREMIER PROPERTY SOLUTIONS, LLC is to be managed by a manager and the name and address of the individual who will serve as the manager is:
