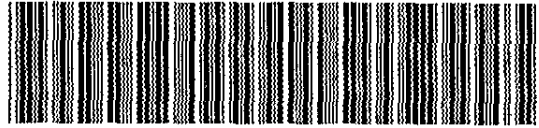

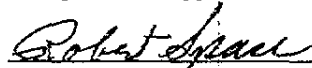

A copy of the stamped Articles of Organization and all certificates of amendment thereto.

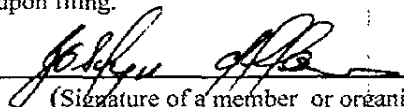

Copies of all tax returns and financial statements for the Company for the past 3 years.

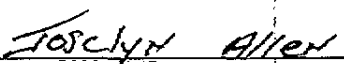
**ARTICLE IX**
