### OF DARLA'S ASSETS, LLC

The undersigned certify that we have associated ourselves for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Amended and Restated Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

- 6.
