The undersigned, for the purpose of forming a **Limited Liability Company** under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization:

ARTICLE I: NAME

The name of the **Limited Liability Company** shall be **Roxika Investments, LLC.**

ARTICLE II: ADDRESS

ARTICLE III: DURATION

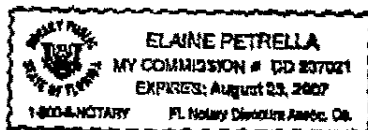


