ARTICLES OF ORGANIZATION

OF

TWIN MEDIA, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statues Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

<u>ARTICLE 1 – NAME</u>

The name of the limited liability company shall be TWIN MEDIA, LLC

ARTICLE 2 – ADDRESS

ARTICLE 3 – EFFECTIVE DATE


These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

ARTICLE 10 - INDEMNIFICATION

The Company shall indemnify managers and officers of the Company who was wholly successful, on the merits or otherwise, in the defense of any proceeding to which the manager or officer was a party because the manager or officer is or was a manager of officer of the Company against reasonable attorney fees and expenses incurred by the manager or officer in connection with the proceeding. All references in these Articles of Organization to "manager," "officer," "employee" and "agent" shall include the heirs, estates, executors, administrators and personal representatives of such persons.
