**ARTICLES OF ORGANIZATION
OF
MEAZELLE M. POST, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be **Meazzelle M. Post, LLC** (hereinafter "company").

ARTICLE III -- DURATION


The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual.

ARTICLE VII -- MANAGEMENT


The company shall be a member-managed company in accordance with the company's operating agreement. The name and address of the initial member-manager of the company is:




