ARTICLES OF ORGANIZATION

OF

GSM VENTURES, L.L.C.



The undersigned, as the authorized representative of the initial member of GSM VENTURES, L.L.C., a Florida limited liability company formed hereunder (the "Company"), on behalf of the members of the Company, hereby forms a limited liability company under the laws of the State of Florida.

ARTICLE I COMPANY NAME

ARTICLE VII MANAGEMENT

The Company shall be a Manager-managed Company.

ARTICLE VIII DISSOLUTION OF COMPANY

The Company may be dissolved only in accordance with the Act or such other documents, rules, regulations or guidelines as may be adopted from time to time by the members of the Company.

ARTICLE IX AMENDMENT TO ARTICLES OF ORGANIZATION


