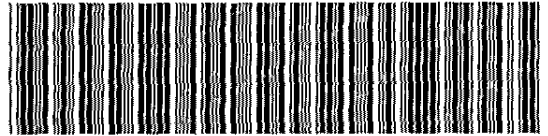

The name and the Florida street address of the registered agent for service of process is Steven Kodsi, 47 East Robinson Street, Suite 210, Orlando, Florida 32801.


ARTICLE IV


