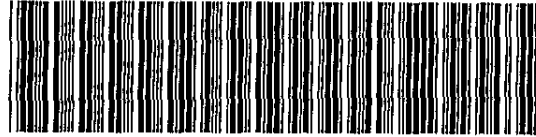


**FIRST:** The Articles of Organization were filed on 08/11/2004 and assigned document number L04000059706.
