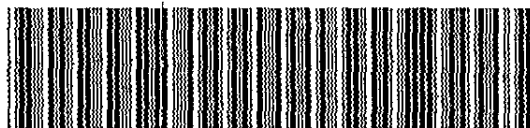

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I - NAME

The name of the professional limited liability company is Nicholas S. Aradi, Ph.D., P.L.

ARTICLE II - ADDRESS




