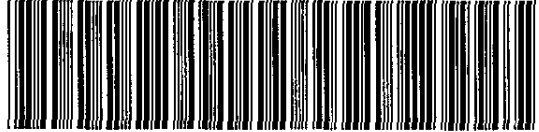

The name of the limited liability company shall be LEPRECHAUN INVESTMENTS, LLC ("company").




