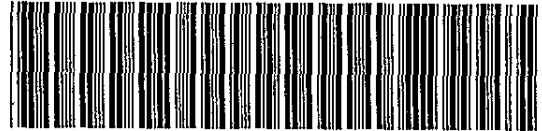



**ARTICLES OF ORGANIZATION
OF

ARTICLE 1 - NAME

The name of this Limited Liability Company is **Wilhelm Aviation, L.L.C.**

ARTICLE II - DURATION

This Limited Liability Company shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE


ARTICLE VI - INDEMNIFICATION


