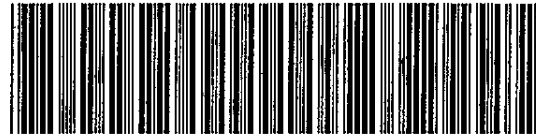



**ARTICLES OF ORGANIZATION  
FOR  
Helcan, LLC**

The undersigned, for the purpose of forming a limited liability company under the laws of the State of Florida, hereby adopts the following Articles of Organization:

**ARTICLE I  
(Name)**

The name of the limited liability company is Helcan, LLC ("the Company").

**ARTICLE II  
(Address)**

The principal office and street mailing address of the Company will be located at 830-13 A1A North, Ponte Vedra Beach, FL 32082.

**ARTICLE III  
(Duration and Continuation)**

The Company shall have perpetual existence, commencing upon August 12, 2004, or such other date no more than five (5) days prior to the filing of these Articles of Organization with the Florida Department of State, whichever is later.

**ARTICLE IV  
(Purpose)**

The general purpose of the Company and the nature of the business to be transacted by the Company are to engage in any and all activities and exercise any and all powers, rights, privileges for which a Company may now or hereinafter be organized under the laws of the state of Florida.

**ARTICLE V  
(Registered Agent and Office)**

**ARTICLE VI  
(Additional Members)**

**ARTICLE VII  
(Members' Rights to Continue Business)**

The right, if given, of the remaining members of the Company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in the Company will be as provided in the Operating Agreement of the Company.

**ARTICLE VIII  
(Members' Preemptive Rights)**

All members shall have preemptive rights with respect to any units by the company subsequent to the date on which such member purchased his or her units. The preemptive right of each individual member shall entitle such member to purchase a percentage of the units to be issued by the company such that his or her proportionate ownership interest in the company will remain the same.

**ARTICLE IX  
(Management)**



The manager will have the obligations and responsibilities described in the Operating Agreement of the Company. The manager(s) will serve in that capacity until removed by the members or until his or her successor(s) is/are duly elected and qualified.
