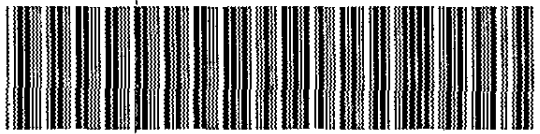



The Company shall commence on August 12, 2004.


