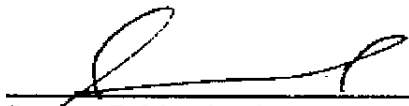
The Company will be managed by its member.

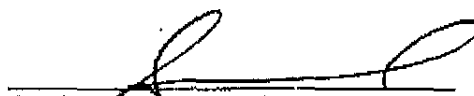
