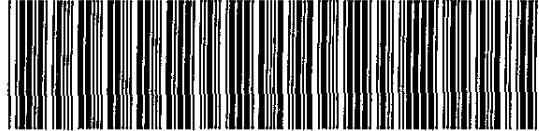

AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF
CHICK COASTAL DEVELOPMENT, L.L.C.

The original Articles of Organization which were filed on August 17, 2004, are hereby amended and restated to reflect that, initially, Chick Coastal Development, L.L.C., is a single member limited liability company in which Martin J. Chick, Jr. is the sole member.

Article I. Name

The name of this limited liability company is **Chick Coastal Development, L.L.C.** ("the Company").

Article II. Address of Principal Office
