## PLAN AND AGREEMENT OF MERGER

THIS PLAN AND AGREEMENT OF MERGER (the "Plan and Agreement") is hereby, adopted by and between Scott Services Group, Inc., a Florida corporation (the "Merking Corporation"), and Scott Services, LLC, a Florida limited liability company (the "Surviving Company"), for the purpose of merging the Merging Corporation with and into the Surviving Company (the "Merger").
