ARTICLES OF ORGANIZATION OF MAJORCA, LLC



The undersigned, being the authorized representative of a limited liability company to be organized under the Florida Limited Liability Company Act, adopts and submits the following Articles of Organization for such limited liability company:

ARTICLE I NAME
