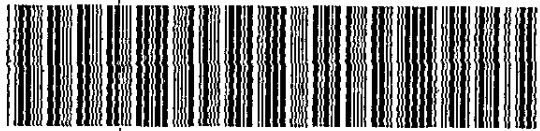

ARTICLES OF ORGANIZATION
OF

RSS PROPERTIES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida limited Liability Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I. NAME



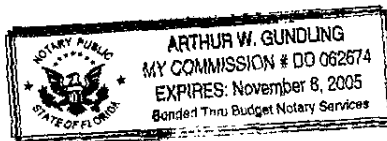
