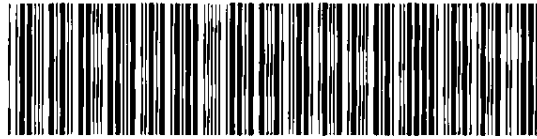

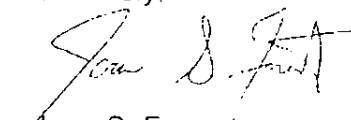
Dear Sir or Madam:

**FIRST AMENDMENT TO ARTICLES OF ORGANIZATION
Of
DAWSON CENTER, L.L.C.**

The undersigned being a Manager of Dawson Center, L.L.C., a Florida limited liability company (the "Company"), in accordance with the provisions of Chapter 605, Florida Statutes, hereby amends its Articles of Organization as set forth below:

1. The name of the company is Dawson Center, L.L.C.

3. Article I -- Organization Name of the Articles of Organization is hereby amended to read in its entirety as follows:
