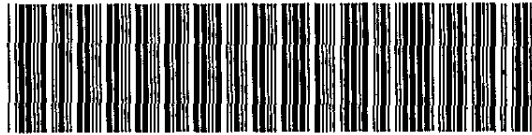



The name of the limited liability company shall be 101 Seaway Drive, LLC ("Company").


