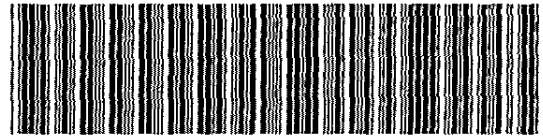

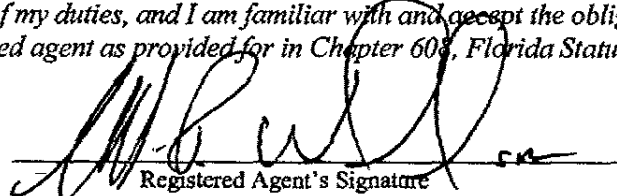

KNOW ALL MEN BY THESE PRESENTS: That Allan R. Wieland, Sr. and Sandy Erickson, desiring to form a limited liability company for the purposes set forth herein and in conformance with the Florida Limited Liability Company Act, do establish:

1. Company Name. That the name of the limited liability company is Aqua-Tech, LLC.

2. Duration. That the period of duration of this limited liability company is fifty years from the date of filing hereof with the Florida, unless sooner dissolved as provided by Florida law.

3. Purpose. That the purpose for which this limited liability company is organized is primarily to provide pool maintenance services, and other goods and services that are permitted by law, within and without the Florida as the laws of Florida and other states permit.

4. Principal Place of Business. That the address of its principal place of business is 8437 S.E. Sharon St., Hobe Sound, Florida 33455.

5. Registered Agent and Office. That the name of its registered agent, whose Consent to Appointment as Registered Agent accompanies these articles, is Allan R. Wieland, Sr., and address of the agent at the registered office is 8437 S.E. Sharon St., Hobe Sound, Florida 33455.

6. Capitalization. That the total capital contributions at the commencement of operations of Aqua-Tech, LLC. of each Member, which is his or its respective undivided interest in personal property having at least a value totaling \$ 1,500.00 should be allocated as follows:

Managing Member, \$1, 500.00

7. Additional Liability of Members. That no additional capital contributions will be required.

8. Admission of Additional Members. That additional Members will be admitted or expelled only with the unanimous consent of all Members entitled to participate in management and upon such terms as are unanimously agreed to by all Members entitled to a dividend upon dissolution or liquidation.

**On or Before June 30, 2005,** Upon successful operation of **AQUA-TECH, LLC.** , Sandy Erickson will be admitted as a member of this Limited Liability Company. She will be entitled to 15% of equity of **AQUA-TECH, LLC.** Allan R. Wieland, Sr. will retain 85% of the equity of this LLC. He will retain his position as Managing Member. Sandy Erickson and Allan R. Wieland, Sr. will share in the Limited Liability Company's annual profit and losses in the same percentages as ownership.

**On or Before June 30, 2006:** Upon successful operation of **AQUA-TECH, LLC.** Sandy Erickson will be entitled to 30% ownership of the Limited Liability Company. Allan R. Wieland, Sr will decrease his ownership to 70% of the Limited Liability Company. Sandy and Allan will share in the Limited Liability Company's annual profit and losses in the same percentages as ownership.

**On or Before June 30, 2007:** Upon successful operation of **AQUA-TECH, LLC.** Sandy Erickson will be entitled to 45% ownership of the Limited Liability Company. Allan R. Wieland, Sr will decrease his ownership to 55% of the Limited Liability Company. Sandy and Allan will share in the Limited Liability Company's annual profit and losses in the same percentages as ownership.

**After June 30, 2007:** Ownership and share of profit and losses of **AQUA-TECH, LLC.** will remain at 55% for Allan R. Wieland, Sr and 45% for Sandy Erickson, unless otherwise determined by amendment to these articles as agreed upon between Sandy and Allan.

9. Continuity of Life. That the remaining Members of the limited liability company may only have the right to continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or occurrence of any other event which terminates the continued Membership of a Member in this limited liability company if they unanimously elect to do so. The return of capital and the distribution of profits shall be determined from the company's books, as of the effective date of withdrawal, based on generally accepted accounting practices, and paid as soon as practicable without diminishing the prospects of the company's ventures and subject to the limitations of the Florida Limited Liability Company Act.

In the event of death, disability or inability to continue operations of AQUA-TECH, LLC. By either Allan R. Wieland, Sr. or Sandy Erickson: In the event of total disability and inability to manage operations for Allan R. Wieland, Sr, the operations of this Limited Liability Company will be managed by Sandy Erickson. In the event of Allan R. Wieland Sr.'s death, his interest in ownership of AQUA-TECH, LLC. will pass to Sandy Erickson. The heirs of Allan R. Wieland, Sr. as detailed in his will, will inherit Allan R. Wieland's capital investment in AQUA-TECH, LLC. at the time of his death.

In the event that Sandy Erickson is disabled and unable to continue managing AQUA-TECH, LLC., Allan R. Wieland, Sr. will assume full management of AQUA-TECH, LLC. In the event of Sandy Erickson's death, the fair market value of her percentage of ownership in Aqua-Tech, LLC at the time of her death will pass to her heirs as specified in her will. Her ownership interest in Aqua-Tech, LLC will revert to Allan R. Wieland, Sr.

- 10 Management. The business of the company shall be conducted under the exclusive management of its Members, or outside managers if its Members unanimously elect, who shall have exclusive authority to act for the company in all matters. Both Allan R. Wieland, Sr. and Sandy Erickson have the right to examine and request an audit of the books and records of AQUA-TECH, LLC. at any time provided they give the other party at least 10 days written notice. At no time shall any family members or related parties of Allan R. Wieland, Sr. or Sandy Erickson be involved in the management or ownership of Aqua-Tech, LLC,
