The private property of the members shall not be subject to payment of the Limited Liability Company's debts to any extent.

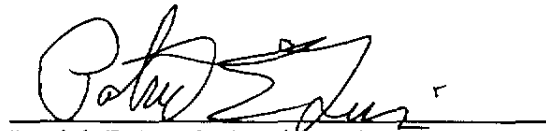
