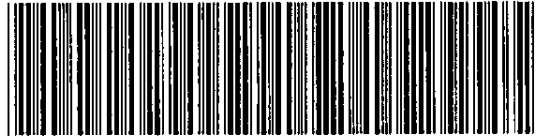

THIS IS TO CERTIFY THAT:

FIRST: This Amended Restated Articles of Organization amends and restates the Articles of Organization of TRANSPORT TRAILER EXPRESS, LLC.

SECOND: The original Articles of Organization of TRANSPORT TRAILER EXPRESS, LLC were filed with the Florida Department of State on August 23, 2004, and assigned Document Number L04000062060.

THIRD: The Articles of Organization of TRANSPORT TRAILER EXPRESS, LLC are hereby amended and restated by deleting the existing Articles of Organization of TRANSPORT TRAILER EXPRESS, LLC in its entirety and replacing it with the following:

**ARTICLE I — NAME:**


