**ARTICLES OF ORGANIZATION
Of
L.I.S. INVESTMENTS, LLC
a Florida Limited Liability Company**

ARTICLE I – NAME

The name of the limited liability company shall be **L.I.S. Investments, LLC** (the "Company").

ARTICLE II – ADDRESS

The mailing address and street address of the Company is 111 Point Circle, Tequesta, FL 33469.

ARTICLE III – DURATION

The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization or in the Operating Agreement.

ARTICLE IV – REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the Company in the State of Florida is: Lloyd Starr, 111 Point Circle, Tequesta, FL 33469.

Having been named as registered agent and to accept service or process for the above stated limited liability company at the place designated in this certificate, I hereby accept the appointment as registered agent and to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in Chapter 608, F.S.

Each member shall make additional capital contributions to the Company only on the written consent of the members owning a majority interest of the Company.

ARTICLE VI - ADMISSION OF NEW MEMBERS

A. New Members. As provided in the Operating Agreement, no additional members shall be admitted to the Company except with the written consent of the members owning a majority of their collective interests in the Company, which consent shall not be unreasonably withheld.

B. Transfer of Membership. A member may transfer all or a portion of his or her interest in the Company only as provided in the Operating Agreement.

ARTICLE VII - MEMBERS' RIGHT TO CONTINUE BUSINESS

As provided in the Operating Agreement, the Company shall not be dissolved on the death, bankruptcy or dissolution of a member or manager.

ARTICLE VIII - MANAGEMENT

The Company shall be managed by a manager in accordance with Operating Agreement adopted by the members for the management of the business and affairs of the Company. This Operating Agreement may contain any provisions for the operation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
