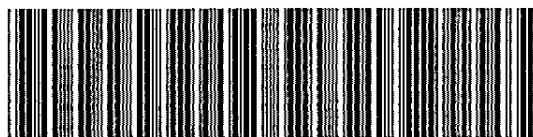




1. NAME OF COMPANY. The name of the Company is:
