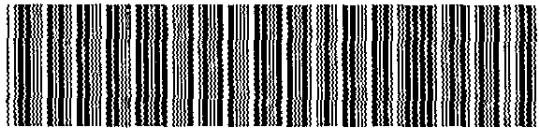

FOURTH: The mailing address and street address of the principal office of the Limited Liability Company is 10231 Emerald Woods Ave, Orlando, FL 32836.






