**ARTICLE III**

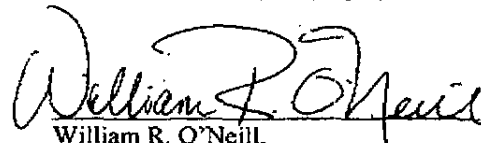
Principal Place of Business
