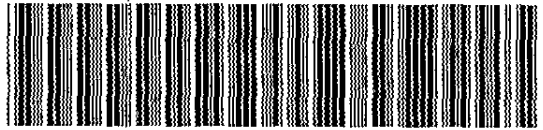

ARTICLE I

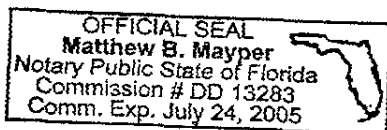


