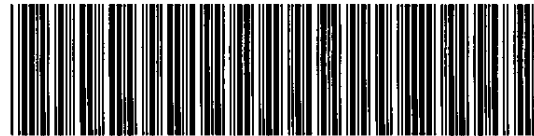





IN WITNESS WHEREOF, the undersigned, as an authorized representative of this limited liability company, has executed these Articles of Amendment on Sept 28, 2007.

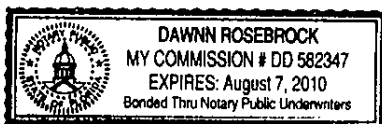
