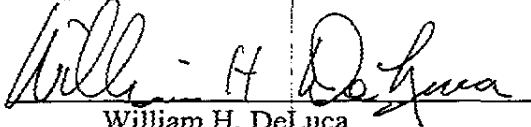
ARTICLE III. MANAGEMENT OF LIMITED LIABILITY COMPANY

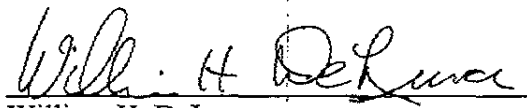
