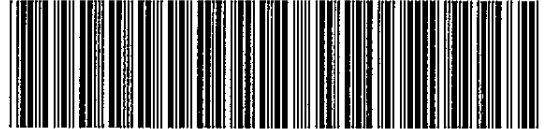

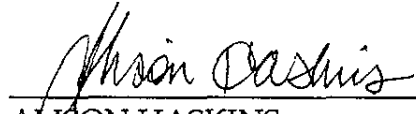
## ARTICLE V - DURATION
