3. A description of the occurrence that resulted in the limited liability company's dissolution pursuant to section 608.441, Florida Statutes:

The company had one member, TERRILL L. VAN PELT. Terrill L. Van Pelt who passed away on October 12, 2012. Florida Statute 608.434 provides as follows:

608.434 Power of estate of deceased or incompetent member; dissolved or terminated member.—

(1) If a member who is an individual dies or if a court of competent jurisdiction adjudges a member who is an individual to be incompetent to manage the member's person or property, the member's executor, administrator, guardian, conservator, or other legal representative may exercise all the member's rights for the purpose of settling the member's estate or administering the member's property, including any power the member had to give an assignee the right to become a member.

(2) If a member is a corporation, limited liability company, trust, or other entity and is dissolved or terminated, the powers of that member may be exercised by its legal representative or successor.

THOMAS W. VAN PELT was appointed as Personal Representative of the ESTATE OF TERRILL L. VAN PELT on November 14, 2012. A copy of Letters of Administration issued November 30, 2012 is attached.

Pursuant to F.S. 608.434, TERRILL L. VAN PELT's personal representative may exercise all of the rights of TERRILL L. VAN PELT for the purpose of settling the member's estate and administering the member's property.

4. Adequate provision has been made for the debts, obligations, and liabilities of the company under F.S. 608.4421.


