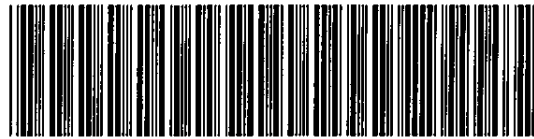

**ARTICLE I-NAME**

The name of the professional limited liability company is "DaVinci Radiology Associates, P.L."

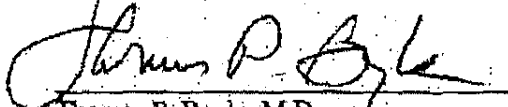

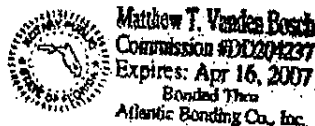

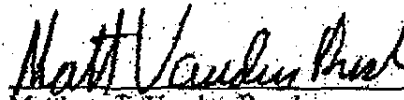
