ARTICLES OF ORGANIZATION OF TGS INVESTMENTS, LLC

ARTICLE I Name

The name of the limited liability company ("Company") is IGS INVESTMENTS.

ARTICLE II

The mailing address of the Company is 8015 Marina Isle Lane, Holmes Beach, Florida 34217, and street address of the Company's principal office is 6500 Manatee Avenue West, Bradenton, Florida.

ARTICLE III Duration

The period of duration for the Company is perpetual.

ARTICLE IV Registered Agent and Office


The name of the Company's initial registered agent in Florida is JOHN EBELSTO. The address of the Company's registered office in Florida is 8015 Marina Isle Lane. Holmes Beach, Florida 34217.

ARTICLE V Management

A. The Company is to be managed by a Manager who will generally serve from annual meeting to annual meeting of the Members or until a replacement is qualified and elected. The initial Manager, however, shall serve until the organizational meeting of the Company and is identified as follows:

JOHN E. BELSITO, whose address is 8015 Marina Isle Lane, Holmes Beach, Florida 34217.

B. The Manager shall have the authority to exercise all powers of the Company and to do all things necessary to carry out its business and affairs described in Florida Statutes Section 608.404, as from time to time amended, including, but not limited to, the power to acquire, mortgage, encumber, sell, lease, convey, and transfer the Company's real and personal property, except:



- a. Reduce the ownership interest, rights, privileges, or benefits or enlarge the duties and obligations of the Members, or:
- b. Enlarge the ownership interest, rights, privileges, or benefits or
 - c, Modify the duration of this Company, or;
- d. Affect the rights or restrictions regarding the assignability of Member ownership interests, or;
 - e. Amend this Article V, or;

reduce the duties and obligations of the Manager, or;

Dissolve or terminate the existence of this Company, or;

g. Do any act that is prohibited by, or fail to do any act that is required by, a resolution of the Members.

If any Member shall not object in writing to the Managers' request for consent pursuant to this Article V within five (5) business days of receipt of such request, such Member shall be deemed to have consented to the Manager's request.

C. A "majority in interest," without more, shall mean a simple majority, as determined by their ownership interest percentages in the Company, of the Members of the Company.

ARTICLE VI Continuation of Business

A majority in interest of the remaining Members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company.

ARTICLE VII Profits and Losses Allocation

Profits and losses will be allocated to the Members in accordance with the Of Agreement of the Company.

ARTICLE VIII Amendments

Subject to the restrictions set forth in Article V above, these Articles may be amended by filing Articles of Amendment with the Florida Department of State signed by a Member and countersigned by a Manager other than the executing Member.

ARTICLE IX Commencement

Pursuant to the provisions of Chapter 608, Florida Statutes, this Company shall begin in existence upon filing of these Articles of Organization with the Secretary of State.
