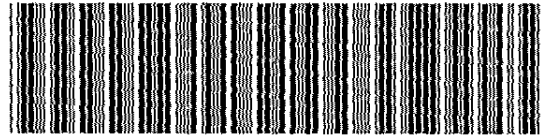

**ARTICLE I  
NAME**

The name of the Limited Liability Company is Z & A HOLDINGS, L.L.C. (the "Company").

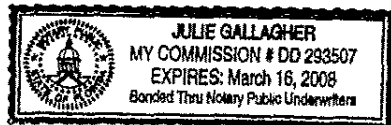
