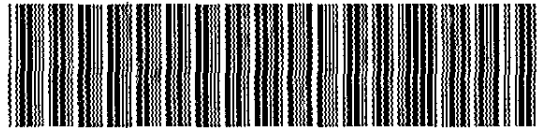

ARTICLE I - NAME

The name of the Limited Liability Company (hereinafter referred to as "Company") is PANHANDLE STEEL & FABRICATION, L.L.C.
