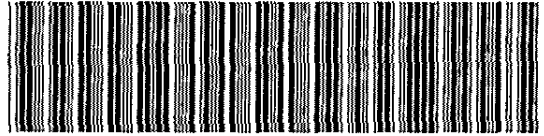

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

**ARTICLE I - NAME**

The name of this Limited Liability Company is CAAMARI2000 PROPERTIES, LLC.

**ARTICLE II - MAILING ADDRESS**

The mailing address and street address of the principal office of CAAMARI2000 PROPERTIES, LLC, 8721 Cypress Reserve Circle, Orlando, FL 32836.

**ARTICLE III - DURATION**

The period of duration for CAAMARI2000 PROPERTIES, LLC shall be perpetual from the date of filing these Articles with the Department of the State, except for the limitations set out in Florida Statutes Section 608.441.

**ARTICLE IV - REGISTERED AGENT & OFFICE**

ARTICLE VII - MANAGEMENT


