ARTICLES OF ORGANIZATION OF

INDRIO PINES. L.L.C.

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608, i.e. the "Act".

- 1. Name. The name of this limited liability company is INDRIO PINES, L.L.C. (the "Company").
- 2. <u>Duration</u>. The Company shall exist from the date of filing these Articles with the Department of State until the earlier of December 31, 2102 or the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining members.
- 3. <u>Purpose</u>. The purpose for which the Limited Liability Company is organized is to operate, manage, improve, repair, rent, lease, own, acquire, sell, assign, mortgage, hypothecate, and otherwise deal in real property and its appurtenances and fixtures; and to deal in direct interests, partnership interests, stockholder interests, and joint venture interests which represent shares in

such property; and to build or contract for the building of of buildings and other structures on such property, and to engage in any lawful act or activity for which a limited liability company may be organized under the Act.

6. Additional Members. Additional members to the Company may be admitted, but only if the current members unanimously agree to the admission of the additional members and to the terms of admission.

- 7. Termination of Mombership. If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the company, the remaining members may, by unanimous written agreement, continue the business of the Company.
- 8. Management of the Company. The Limited Liability Company is to be managed by one manager or more managers and is, therefore, a manager-managed company. The following member will initially be the managing member:

- 9. Limitation on Agency, Authority of Members. No member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member. Such authority shall be reserved for the managing member of the Company.
- 10. Regulations or Operating Agreement. The members shall have the power to adopt, alter, amend, or repeal regulations or Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
