The name of the Company is QMS Investments, LLC.

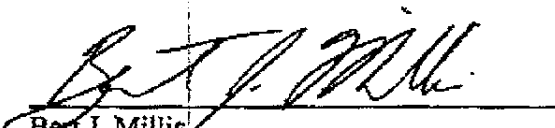
ARTICLE II - PRINCIPAL OFFICE
