ARTICLES OF ORGANIZATION OF MAYFAIR AR INVESTMENTS, LLC

TALL AHASSEE FLORID. The undersigned member(s)/manager(s), for the purpose of forming a Limited Liability Company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of Limited Liability Companies adopt the following articles of organization:

ARTICLE L NAME

The name of the limited liability company shall be: MAYFAIR AR INVESTMENTS, LLC

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

The street address and the mailing address of the limited liability company's initial principal office shall be: C/o Frank Amsalem, Esq., 777 Arthur Godfrey Road, Second Floor, Miami Beach, FL 33140.

ARTICLE III. EXERCISE OF POWERS

All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed under the direction of, the members of this limited liability company. This Article may be amended from time to time in the regulations of the limited liability company by a unanimous vote of the members of the limited liability company.

ARTICLE IV. MANAGEMENT

This limited liability company shall be managed by one (1) manager. The name and address of the person who shall serve until the first annual meeting of members or until a successor(s) who is as follows:

ARTICLE V. MEMBERSHIP RESTRICTIONS

Members shall have the right to admit new members by unanimous consent. Contributions required of the new members shall be determined as of the time of admission to the limited liability company.

A member's interest in the limited liability company may not be sold or otherwise transferred except with unanimous written consent of the majority of members.

On death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member of the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to continue the bis member of STATE unanimous consent of the remaining members.

ARTICLE VI. DURATION
