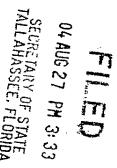

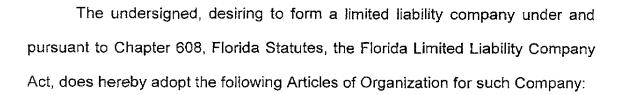

## ARTICLE XI Transferability of Members Interest

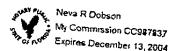
