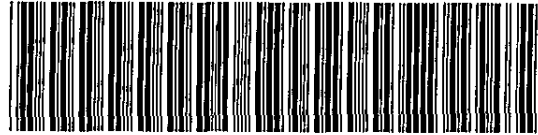

The mailing address and street address of the principal office of the Company is 21007 NE 32nd Street, Aventura, FL 33180.


ARTICLE III - Registered Agent and Office
