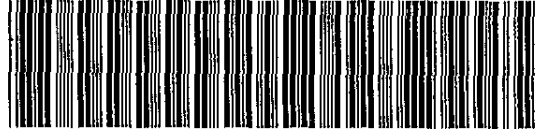

ARTICLES OF ORGANIZATION
OF

ARTICLE I
Name of Company

Tater's Home Improvements, LLC

ARTICLE II
Business of Organization

The limited liability company may engage in the business of home repairs and maintenance, and may also engage in any other lawful activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III
Principal Place of Business



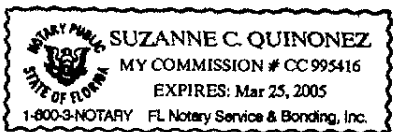
