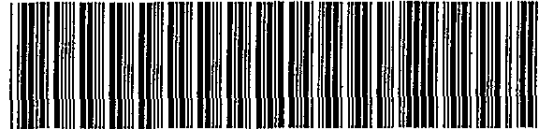



**ARTICLES OF ORGANIZATION OF  
TAMPA DIALYSIS, LLC**

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida sets forth the following:

**ARTICLE I: NAME**

The Name of the Limited Liability Company is: Tampa Dialysis, LLC

**ARTICLE II: ADDRESS**

The Mailing Address of the Principal Office is: 409 Bayshore Boulevard, Tampa, Florida 33606.

The Street Address of the Principal Office is the same.

**ARTICLE III: DURATION**

The duration for the Limited Liability Company shall be perpetual.
