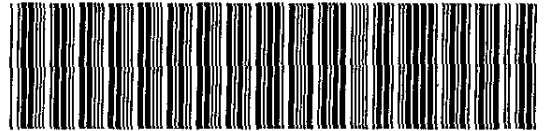

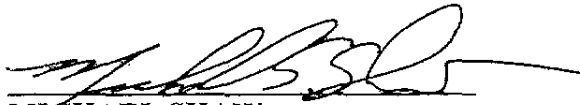

**ARTICLE IV-MANAGEMENT**

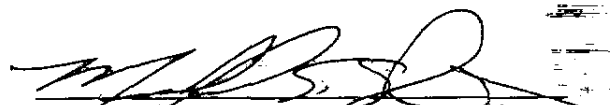
