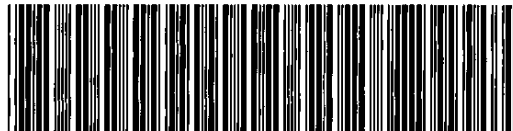

The Articles of Organization are amended as follows:



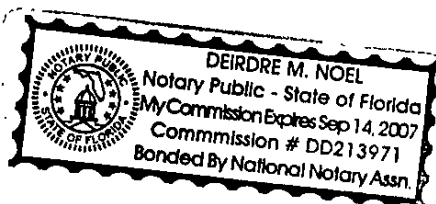

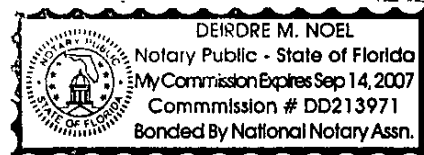
