

ARTICLES OF ORGANIZATION

OF

SPRING TIDE INVESTMENTS III, LLC

ARTICLE I NAME, PRINCIPAL ADDRESS, AND MAILING ADDRESS

The name of this limited liability company is SPRING TIDE INVESTMENTS III, LLC and the initial principal address and mailing address of the limited liability company is 622 Bypass Drive, Suite 100, Clearwater, Florida, 33764.

ARTICLE II NATURE OF BUSINESS AND POWERS

The general nature of the business transacted by this limited liability company is to engage in any and all business permitted under the laws of the State of Florida.
