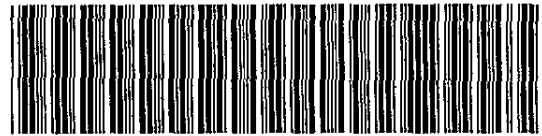

**ARTICLES OF ORGANIZATION

The undersigned, being a natural person of at least 18 years of age and acting as the Organizer of the Limited Liability Company hereby being formed under the Chapter 608 of the Florida Statutes, does hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:


Marenate, LLC

FIFTH: The mailing address and principal office of the Limited Liability Company is 5 Via DeLuna, Pensacola Beach, Florida 32561.

SIXTH: The Limited Liability Company is to be managed by a Managing Member. The name and address of the initial Managing Member is: Robert A. Mackey, having an address at 1046 Edgewater



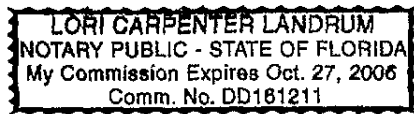
